Subject:-Decision regarding revised monetary penalty in respect of appointing physically absent but present only on paper teacher-regarding.

Sir/Madam,

In continuation to the office letter of even no. dated **08.08.2024** in accordance with section 28(1)(f) of NCISM Act 2020, regulation 3(1)(f) of RMS, 2016, as per the letter of MARBISM vide letter no 26-75/2021-visitation, dated 31/8/2021 and letter no.3/2022/MARB/General Matter, dated 17/8/22, a penalty of **Rs. 1,50,00,000/-** was imposed as six faculty of your institution namely **Dr. Ardra Ajayakumar (AYDG01610)**, **Dr. Arvind Kumar Payasi (AYKB00908)**, **Dr. Basayya Ishwarayya Mathapati (AYRB00212)**, **Dr. Payal Abhijit More (AYRN01132)**, **Dr. Ramesh Sir Patil (AYST00195)** and **Dr. Sivakumar Dande (AYSK00531)**, were found to be physically not present but working only on paper and same was communicated to you vide letter of even no. dated **08.08.2024**.

Further, request letters were received from **Dr. Ardra Ajayakumar (AYDG01610)**, **Dr. Arvind Kumar Payasi (AYKB00908)**, **Dr. Basayya Ishwarayya Mathapati (AYRB00212) Dr. Sivakumar Dande (AYSK00531)**, **and Dr. Ramesh Sir Patil (AYST00195)** along with documents requesting to reconsider the decision and to consider them as a regular faculty.

In this regard all the evidences provided by faculties and by the college have been re-verified by the designated committee and observation of re-verification, by the committee is as follows:-

- 9. Various medical reports and investigation reports regarding miscarriage and necessity to take bed rest. Considered as proof for valid reasons for absence during both visitations.
- Mobile pictures of faculty in the college & outside on various dates both before visitation and after visitation. Considered.

- 12. Documents for money remittance (Electronic) for various purchases Considered
- 13. Salary slips for different months.
- 14. Leave letters & attendance register.

### Conclusion:-

Submitted documents indicate that faculty is staying in the college campus along with her husband who is also a faculty in the same institution. Documents justify her absence during both visitations. Regularity can be considered Based on submitted documents for Gas connection, Purchase bills and photos before & after visitations. Hence, faculty can be considered as regular.

- UP State Registration Certificate issued on 30/12/2014.

Conclusion:- Submitted documents indicate that faculty is attending to the college. However, they do not prove the regularity. Hence, faculty is neither considered as regular nor as on paper faculty.

- 8. Salary slips of various months. Can be Considered.
- First page of Passbook- Details not legible.
- 10. Attendance Register for the Period from Jan 24 to June 24. There is gross mismatch in signatures done on pages of different months. -Not Considered.
- 11. Photos of faculty in the college with no dates. It appears that most of the photos are taken on a single day. Not considered.
- 12. Photos of practicals in RSBK. Out of 38 photos, faculty is seen in only one photo. Not considered.
- Videos of practicals at RSBK. Faculty is not seen in these videos. Not Considered.

# Conclusion: - Submitted documents do not prove the regularity of the faculty in institution. Hence, he is not considered as a regular faculty.

- Room allotment letter issued by the institute, dated 11/12/2021 Considered but it does not prove the regularity.
- Application for updating AADHAAR, dated 17.08.2024. Document does not show any request for change of address. – Not considered.
- 3. Bank statement of faculty, showing local address of faculty Considered but it does not prove the regularity.
- 4. Leave application dated 10.02.2024 for the period from 12.02.2024 to 19.02.2024 to justify his absence during second visit. Submitted other application for leave on various other dates. Gross mismatch in the applications found in terms of handwriting of applicant and signature. Application dated 10.02.2024 is an image of the copy whereas remaining applications are image of original document. Also signature of applicant and substitute faculty appears to be same Not considered.
- 5. 11 photos of the faculty taken on 21/06/2024 on the occasion of International Yoga Day. Additional about 12-13 photos showing faculty. Most photos are of a function at college, classroom photos do not show the faculty.

   Not considered, as these do not prove regularity.
- 6. Proof of purchase through Flipkart two tax invoice- can be considered.
- 7. Attendance Register for the period from Jan 2024 July 2024. Mismatch in Signature observed Not considered.
- 8. Time table dated 21.06.2024, time table does not mention practical classes. -Not considered.
- UP Registration certificate issued on 22/06/22. Name of the Practitioner is mentioned as Dr. Rama Reddy instead of Dr. Ramesh Sir Patil. It is observed that name is Rama Reddy in KAUP Registration certificate & Degree certificate uploaded on OTMS.

Conclusion:- Submitted documents do not indicate the regularity of the faculty at institution. Hence, faculty is not considered as regular.

Conclusion:- Submitted documents do not the prove the regularity of the faculty in the institution. Hence, the request of the faculty cannot be considered. Faculty is not considered as regular.

Further, the recommendation of the committee members was placed in 106<sup>th</sup> & 108<sup>th</sup> Board meeting of Medical Assessment and Rating Board for Indian System of Medicine, NCISM and board discussed and approved the same.

Therefore, it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine, NCISM to certify Dr. Ardra Ajayakumar (AYDG01610), as regular teacher and Dr. Arvind Kumar Payasi (AYKB00908) as neither regular nor as on paper faculties in SCPM Ayurvedic Medical College & Hospital Lucknow Road, Haripur Gonda-271003, for academic session 2024-25. The benefit of doubt goes in favor of the faculty. Hence, Board decided to revise the imposed monetary penalty of Rs. 1,50,00,000/-.

Therefore, in view of the above decision of the board monetary penalty of **Rupees One Crore Only (Rs. 1,00,00,000/-)** is imposed on your institution in accordance with section 28(1)(f) of NCISM Act 2020 as per the letter of MARBISM vide letter no 26-75/2021-visitation dated 31/8/2021 and letter no.3/2022/MARB/General Matter dated

17/8/22, and as per MESAR 2024, Chapter X, 71, 1, 2, 3 as four (04) of your faculty namely Dr. Basayya Ishwarayya Mathapati (AYRB00212), Dr. Payal Abhijit More (AYRN01132), Dr. Ramesh Sir Patil (AYST00195) and Dr. Sivakumar Dande (AYSK00531), as mentioned above are found to be physically absent but working only on paper and the documents submitted by the faculties are not enough to substantiate their regularity in your institution.

Further imposed penalty of Rupees One Crore Only (Rs. 1,00,00,000/-)is to be remitted in the account of NCISM the details of which are as follows: -
